What we do	
How does United Auto Credit <sup>®</sup> protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

Affiliates	<ul> <li>Companies related by common ownership or control. They can be financial and non-financial companies.</li> <li>Our affiliates include, but are not limited to, Vroom, Inc., Vroom Automotive, LLC, Vroom Automotive Finance Corporation, Vroom Finance Corporation, UACC Auto Financing Trust III, UACC Auto Financing Trust IV, UACC Auto Financing Trust V, UPFC Sub I, Inc., and VFS Near Prime Trust I.</li> </ul>
Non-Affiliates	<ul> <li>Companies not related by common ownership or control. They can be financial and non-financial companies.</li> <li>Non-affiliates we may share with can include auto dealerships, insurance companies, and other financial institutions.</li> </ul>
Joint Marketing	<ul> <li>A formal agreement between non-affiliated financial companies that together market financial products or services to you. Our joint marketing partners could include:</li> <li>Insurance companies, automobile dealers and credit products and service companies.</li> </ul>
